In consideration of the purchase price of \$ \_\_\_\_\_ dollars, the Seller transfers all rights, privileges and responsibilities associated with ownership of the puppy to the Purchaser as of the date specified above.

Seller: Guarantees the puppy specified above to be free of communicable disease for a two-week period from date of sale (possession) and untreatable/life-threatening congenital defects until the puppy turns one year old.

This guarantee does not include minor illnesses and health issues such as colds, allergies, internal or external parasites or umbilical hernias. We do not guarantee fur color, eye color, adult size, conformation, reproductive ability, personality, training ability, proper bite, coat quality, length, weight, hernias of any kind, and any physical flaws. However, the breeder will disclose any known illnesses or health issues prior to the sale and strive to pair the Purchaser with the puppy they want.

Purchaser: The Purchaser agrees to have the puppy given the vaccinations and/or deworming required as stated in the puppy health record on or around the due dates. They also agree to take care of the puppy to the best of their ability.

Picture Policy: The Purchaser agrees to allow the Seller use of any pictures of the puppy that the Seller acquires. These pictures will be used to show future buyers what the puppies look like as they grow. Any people in the pictures will be edited out unless permission to use the picture “as is” is given.

Return Policy:

If there are any communicable diseases found by a licensed vet within the first two weeks after purchase or if there are any untreatable/life-threatening congenital defects found by a licensed vet until the puppy turns one year old, the buyer can return the puppy for a full refund if they:

1. Agree to return the puppy to the seller with a letter from the vet specifying the problems with the puppy, dated within the time period noted above.
2. Provide the Puppy Purchase Agreement/Health Contract completed between Purchaser and Seller, all health records, and any other important records or items pertaining to the puppy.

The Seller is in no way responsible for any medical, veterinary or travel expenses incurred by the Purchaser of this puppy after the date of sale listed above. This Agreement is non-transferable.

If these requirements are fulfilled then the puppy can be returned to the Seller and the Purchaser can receive a full refund. The Seller is allowed two years from the return date of the dog to get the refund to the Purchaser. Our intent is for the Purchaser to enjoy a healthy and happy puppy.
