Conditions Stud Owner Agrees to:

1. Take normal adequate care of the bitch while in our charge.
2. Have the stud dog in good physical condition.
3. Provide a return stud service to the same bitch if no pregnancy results from the first mating. To receive the return service, the bitch owner must notify the stud dog owner of failure to conceive, not more than 65 days following the mating.

Bitch Owner Agrees to:

1. Pay the agreed stud service fee, including deposit, as soon as the puppies are two weeks old. Or the \$100 increased stud fee once the puppies are eight weeks old.
2. Have the bitch in good physical condition.
3. Notify stud dog owner no later than 65 days after mating if no pregnancy results.
4. Bitch owner warrants that she has not been bred to any other stud dog from the start of her heat cycle.
5. Keep her properly confined following the breeding to ensure no other dog could mate her accidentally before mating season is finished.

Stud Fees/Expenses:

1. A stud fee of \$ _____ shall be payable in full as soon as the puppies are two weeks old. The stud fee can be paid in cash, check, or US Postal Money Order. **At the breeding \$100 of the stud fee is due and this amount is non-refundable.** Also if you wish to wait to pay the remainder of the stud fee until the puppies are eight weeks old, there is an increased fee of \$100 added to the stud fee. **Please notify the stud owner if you decide to wait till they are eight weeks old to pay the remainder of the stud fee.**
2. The bitch owner is responsible for any and all fees associated with the birth and care of the puppies and the dam.
3. The owner of the stud dog guarantees that the bitch whelp 2 puppies. If the bitch fails to whelp or whelps less than two puppies, the owner of the bitch must notify the stud dog owner within 7 days of the expected whelp date. In these cases, the stud dog owner will provide one repeat stud service to this bitch.
4. In the case that the bitch changes ownership, there is no obligation on the part of the stud dog owner to provide a repeat service.
5. If the bitch fails to conceive on the second return service, this contract is satisfied.

In breeding animals, there is always a risk that one may be injured during the process. Bitch owner agrees to hold the stud dog harmless from any liability or damage. In addition, the bitch owner understands that the stud dog owner accepts no liability for the actions of this bitch while in their care, including but not limited to personal injury, death, or property damage. If medical care is needed for bitch (bitch owner will be contacted immediately) and if the bitch owner cannot be reached, stud owner has permission to take to a vet and will be reimbursed by bitch owner.
